15.1 AAC paid standing ovation to Hon. Vice Chancellor Dr. K. P. Joshipura who has resumed charge as Vice Chancellor of Saurashtra University Rajkot. AAC resolved :

**Dr. K. P. Joshipura has taken a charge of Hon. Vice Chancellor of Saurashtra University, Rajkot from 04th August, 2005. Dr. Joshipura is a Chairman/Chairperson of Academic Advisory Committee of ASC as per the UGC Guideline.**

- 15.2 The minutes of the AAC held on 01st August, 2005 was formally sanctioned by the than Vice Chancellor. Dr.Bhadrayu has given action taken details of last minutes. Members expressed satisfaction about all matters.
- 15.3 The work progress of academic activities of ASC was discussed and reviewed in full length. **04** RCs and **03** collaborative academic activities were narrated by the Member Secretary. Total 100 participants were trained during 02.08.2005 to 12.12.2005 in RCs.
- 15.4 AAC empowered Hon. Vice Chancellor / Chairperson to nominate two experts for the interview for the post of Reader, ASC, SU, Rajkot.
- 15.5 During the discussion about the status of ASC in Saurashtra University, Dr.Rupaben Shah clarified that acedemic staff of ASC may be from various faculties. They must be assigned respective faculty they belong to. Dr. Joshipura appointed a committee to study the issue, to review Saurashtra University act and statute, to decide about the matter and to give clear decision whether... (1) ASC can be considered as department ? (2) Academic Staff can be considered as faculty members ?. Four member committee consisted of (1) Prin. Ramesh Fuletra (2) Dr. D. A. Uchat (3) Dr. R. Kalaria (4) Dr. Bhadrayu. Hon. Chairman insisted that before the end of this academic year this must be clarified and action will be taken by Hon. Vice Chancellor on the report of the committee.
- 15.6 AAC discussed at length about the staff position of non-teaching staff of ASC. All members expressed concern about 'no steps taken by University Authority to fill up non-teaching staff / posts sanctioned by UGC and State Government. AAC strongly resolved that : "All non-teaching posts at ASC sanctioned by UGC and approved by State Government wide its letter no.Sau:1096-665-(35/92)-KH; dt : 16.7.97 filled up at the earliest by giving advertisement separately only for ASC, SU, Rajkot." Chairman, AAC instructed I/C.Registrar and CAO, who were present at the meeting, to expedite this matter at the earliest but before 31st March 2006.
- 15.7 With the permission of the Chair, the list of the Resource Persons to be invited by ASC during OP and RC, was put up for the consideration of the AAC and members sanctioned the same.
- 15.8 AAC discussed the details of incoming programmes and expressed satisfaction over the efforts of ASC to manage the show in constrains of low turn out of participants and non availability of sanctioned post.
- At the end of the meeting Prof.-Director ASC conveyed thanks to the Chairman & all AAC members for their valuable presence.
